

Subject:- Reassigning of Customs functions that are presently being performed by the officers of Central Excise - regarding.

Consequent upon the proposed reorganization of the Customs formations w.e.f. 1st January 2018, the Customs functions that are presently performed by the officers of Central Excise would be reassigned. The indicative list of such functions is enclosed as per the Annexure. Keeping in view the Government's emphasis on the expeditious clearance of EXIM Cargo and ease of doing business, it is imperative that both the CGST (erstwhile Central Excise and Service Tax) and Customs formations work in coordinated manner to ensure smooth transition. Accordingly, field formations are being instructed for safe and proper transfer of files to ensure seamless transition without any disruption.
